COLLEGE NOTES

WE have to record with the greatest regret the loss of two Fellows by death in the past year. Mr. Jackson was a member of the old Magdalen Hall, and while he was not much known to those of recent years he was a very prominent figure in Oxford in his prime. Although his death came as a release after a long period of paralysis and partial unconsciousness, it will be felt by many as a severance of a very definite link with the past. Mr. J. E. Campbell's death was absolutely unexpected, since he was in full performance of his duties as Tutor, and indeed appeared to be in the best of health. It is not often that a college suffers so intimate a loss. We are glad to learn that he had just completed his second book.

A memorial service was held in the Chapel on February the 8th for both Mr. Jackson and Mr. Campbell; the Bishop of Carlisle dedicated two panels in the ante-chapel, in the presence of a number of relatives and friends.

A Committee of athletes and other friends of Mr. Jackson has been formed for the purpose of raising a fund to commemorate his work as a pioneer in the organization of University Athletics. It is proposed to circularize Old Members and others who might be interested. The treasurer is J. Wells, Esq., Wigod House, Wallingford.



Another loss the College has to regret is the death of Sir Thomas Jackson, who was the architect for so many of the recent buildings in Oxford and especially in Hertford. We owe him the Hall, the north front of the Old Quad, the Chapel, and all the New Buildings, and it was one of the ambitions of his later life to see the Octagon finished.



The delay in completing the Octagon is deplorable from every point of view, but of course conditions have been very difficult. It was hoped that a photograph might appear in this number of the Magazine, but so far there is not much to see except a foreground of hoardings and scaffoldings. However, we still have hopes that we may expect to find everything ready for occupation with the beginning of the Autumn Term.



Mr. Haselfoot has had to resign the Bursarship owing to ill health, not unconnected, we fear, with his conscientious application to this particularly thankless job. He has been Bursar through part of the difficult post-war period, and through the re-drafting of Statutes consequent on the Royal Commission's Report. We sincerely hope that now he is less hard-worked he may regain his health. The post has for the present been taken over by Mr. Murphy, who has served a sort of apprenticeship as Treasurer of the Amalgamated Clubs.



We offer our congratulations to Lord Hugh Cecil, who is, of course, still a Burgess for the University, on his Hon. D.C.L. received at the last Encaenia. It is, we believe, the first time that this honour has been conferred on a Hertford man.

We extend a very hearty welcome to the Reverend A. M. Hollis, who has followed Mr. Campbell as College Chaplain. He was at school at Leeds, and after that was in the Guards Machine Gun Regiment from January 1918 to April 1919, though he was not called upon to go out to the front. He took a first in Greats in 1922 and orders in 1923.

As we go to press we learn that we may also welcome Mr. C. H. S. Fifoot, who has been elected Fellow and Law Tutor. He came to Exeter from Berkhamstead, after a period in France as a gunner, in which he was wounded. After taking a first in Law he went to the Middle Temple and also got married. Since then he has been on the South Wales Circuit.

C. N. JACKSON

ON the 28th October 1924 died Clement Nugent Jackson. He had been so long an invalid that scarcely any even of the Fellows of the College knew him by sight, but for nearly fifty years it is not too much to say that his influence was paramount in the College and in far wider circles. Born at Simla in 1846, he went to Somerset College, Bath, obtained a scholarship at Magdalen Hall in 1864 and took Honours in both Classical Schools. But he was chiefly known as an athlete. In 1866 he did not run, probably through overtraining, but in 1867 he won the Hurdles against Cambridge. The time was $17\frac{1}{4}$ secs.—but he was credited with having done 16 secs. on the old Marston ground. In that year he lamed himself in practice and never ran again.

After taking his degree he remained in residence as a private Tutor and when the new Hertford College was founded in 1874 he was appointed a Tutor.

Before that time he had taken over the permanent Treasurership of the O.U.A.C. and for the rest of his active life it is his financial and administrative capacity that is most in evidence.

In 1876 he procured, equipped, and financed the present Athletic Ground and incidentally obtained the use of it for the College games, which use continued until two years ago.

It was in Oxford in 1880 that the important meeting was held that resulted in the formation of the Amateur Athletic Association which controls all the meetings in the country. Jackson was one of the moving spirits and was appointed its first treasurer, which office he held for many years. In 1881 he was Senior Proctor and was elected a Fellow of the College. This fellowship he vacated when he married in 1886, but he was afterwards elected to another—a 'married' Fellowship.

It was in 1883 that he made what was probably the most far-reaching of his reforms by amalgamating all the College clubs. This has been imitated by all other colleges, and without this plan it is hard to see how, in present times, all the various athletic activities could be carried on. He remained Treasurer of the Amalgamated Clubs until his final retirement in 1913. In 1890 he became Bursar of the College and remained so until 1913.

Whenever a club found itself in financial difficulties he was called in. In 1886 he became Treasurer of both Varsity Football Clubs. He obtained the present Rugby ground and Pavilion. In 1900 the Tennis Club called for his assistance, and in 1903 the Lacrosse Club.

It will be seen that though he was most interested in his first love—Track Athletics (he was always prominent at the Varsity Sports and Championship Meetings)—he was a keen supporter of all healthy forms of sport. He himself used to go a great deal to Norway for fishing. Many generations of Oxford men must owe him a great deal for their early encouragement.

A word or two of personal recollection. When I came up in 1876 he was the Fellow with whom we came most in contact, and we looked up to him with the greatest respect; we could be sure of advice and encouragement if we went to him. He was a particularly neat man and rather autocratic in his manner, but really very friendly. Though he was not a rowing man, he used to come down and run with the boat races. We could always hear him and could depend upon his calling us exactly how we stood. He encouraged sports because he thought they produced the right type of man, certainly not to the exclusion of other interests. He would stand no sort of nonsense. If a man is to be measured by his influence on other men Jackson must be accounted a great man.

J. E. CAMPBELL

By the death of J. E. Campbell the College has lost one of its most distinguished Tutors, and a mathematician who for many years brought by his great reputation Scholars to the College who won distinction in the Schools. He was among the first, if not the first, of Hertford undergraduates to win a Fellowship; he never left the College after his election; throughout his life he made the success of the College his principal object of ambition.

It is difficult to appraise too highly the value to an Oxford college of such lives. Few men in the present day are prepared to devote themselves wholly to the service of a comparatively small society if by their gifts or capacities they can win wealth or reputation in a larger world. Still fewer are capable of making this sacrifice and of managing at the same time by intense concentration of energy to make an important contribution to the general stock of human knowledge.

Campbell was successful in both these achievements. No more devoted Tutor ever won his pupils' affectionate gratitude. As a contribution to geometrical research Campbell's books have been among the most highly praised in recent years.

Yet those who knew him best, and especially his old colleagues,

valued him chiefly as a man. Even casual acquaintances commented on his obvious 'goodness'. Those who knew him intimately realized how great was his unselfishness and the depth of his devotion to the principles upon which he based his life.

Extreme modesty amounting almost to self-effacement kept him from playing any very prominent part in University affairs. And that inability to understand the amount of accuracy attainable in practical affairs which Aristotle noted as a mark of the mathematical mind made him somewhat unstable, almost whimsical in his judgements upon matters concerning the administration of a college. Yet his colleagues felt that so far as deeper motives influencing judgement were concerned they would prefer to be wrong with Campbell than right with any shrewder man of the world.

And in his own administrative offices he showed first-rate capacity. He took over the Bursar's work at a time of great urgency and considerable embarrassment. He performed it admirably. He acted in a similar capacity for Lady Margaret Hall and won the lasting gratitude of all whom he helped there by his wise and timely counsel and unwearying work. Yet always his mathematical interest was paramount, and it was with great relief that at an early moment he went back to the chief labour of his life.

It would not be right to conclude this inadequate notice without mention of one other aspect of Campbell's character upon which it is obviously impossible to write at length. He was a man of great simplicity, and simple people are influenced more than others by their natural affections. In his love for his family and his home Campbell found his deepest happiness. The success of his children brought him far greater delight than any fame which he himself had won; the sorrow which he experienced during the War left as deep a mark upon him as it could leave upon any who in those years suffered a tragic loss.

He was sustained by a religious faith at once as deep and as simple as was most of the other qualities by which he lived.

The enjoyability of the occasion was greatly increased by the perfect weather; a summer evening in the quad was pronounced by all to be better than a spring one indoors, and reminiscences were prolonged to a late hour.

THE HOP-PICKING SETTLEMENT

AFTER considerable discussion, it has been decided that, with John Campbell's departure, the hopping camp could no longer be usefully continued. Undoubtedly the success achieved at Crowhurst, and so strikingly shown by the Hoppers' farewell to 'John', was very

largely a purely personal one, and was due not only to the weeks spent in camp, but also to constant visits in the Christmas and Easter vacs. ; visiting which cannot now be carried out. The constant inquiries, however, on the part of the Hoppers, as to the future of the camp show that the absence of any college contingent will quite definitely affect the general life of the camp, and be felt as a real want ; and it is much to be hoped that various negotiations, at present in hand, may come to a successful issue, and that a successor to Hertford will be forthcoming. They may be sure of a very hearty welcome at Crowhurst.

The question then arose of some new activity for the College : a meeting was held at the beginning of this term to discuss the possibility of associating ourselves with ' Decima Club ' in Bermondsey. Decima was originally founded by a Hertford man, Dunlop, and for a time was known as Hertford Club : it still retains its red and white colours. A new connexion is now to be formed, and the meeting decided in favour of an attempt, without any alteration in the existing management of the Club, to form some definite and close relationship with Decima, and ensure it some steady support and friendship. The Principal outlined the project at the meeting. Mr. Dunlop told of the early history of the Club, and Mr. Alec Patterson expounded, as he alone can, the ideals of ' Oxford and Bermondsey '.

TYNDALE SOCIETY

THE Tyndale Society has passed through a fairly successful year, in spite of a certain amount of apathy during the Michaelmas Term—an apathy due probably to the imminence of schools for most members. Several freshmen and new members have recently been admitted, and their advent has been marked by an increased interest in the proceedings of the Society.

Four meetings were held last Summer Term, one of which, Mr. Denniston's paper on 'Purism', provoked a discussion which lasted well into the night, and was even further prolonged by some members who were to be found in corners of the quad, wrangling deliriously in the small hours. Clemence Dane's *Will Shakespeare* was also read at one of the meetings in this term.

In the Michaelmas Term eight meetings were held, Mr. Hignett reading a paper on 'Veracity', the play for the term being Bernard Shaw's *Caesar and Cleopatra*.

Mr. John Buchan's paper was the most popular meeting of the Hilary Term and was attended by twenty persons. The thanks of the Society are due to Mr. Buchan and also to Mr. Brett-Smith for a paper on Caxton's 'Ovid', and to the Rev. A. M. Hollis for one on 'Reticence'.

CHRISTIAN UNION

DURING the Michaelmas Term the Christian Union divided its activities by devoting half of its time to questions of a social and half to questions of an apologetic nature, and many good discussions were held. Especially fortunate were we in hearing J. W. Parkes on Pacifism. During the Hilary Term it was felt that this division, although possibly enabling us to cover more ground, yet led to lack of unity and a general vagueness in results. So it was considered more profitable to restrict discussion to one definite theme. Accordingly the papers and discussions were based on a short book, 'God and the World' by the Rev. Dr. Robinson, by the help of which the Union has surveyed religious thought from Paley to the present day. We think the event justified the scheme.

Arrangements for Swanwick are being started early this year, and it is hoped that many will find it possible to attend this conference.

LEAGUE OF NATIONS UNION

THE activities of the organization during the past year we regret to say could be only too briefly narrated. The depression is past and a period of rejuvenation seems to be setting in, but our numbers are reduced to a mere remnant. We feel that the present state is not so much due to apathy as to ignorance. To the vast majority the Covenant and the Geneva Protocol are mere names, and they do not realize that apart from its primary object, the maintenance of World Peace, the League is a gigantic International Co-operation which deals with such evils as the opium traffic, which could never be effectually dealt with under the old pre-war system. The League is a practical working organization, but it needs driving power, and the purpose of the League of Nations Union is to supply some of that power by encouraging study of the League's activities and difficulties.

OFFICERS' TRAINING CORPS

THE interest in the Corps evinced by the College is still mainly impersonal, as it has been since the War. We hope that this regrettable state of affairs will be improved by next year.

The real prejudice against the Corps seems to be founded on the idea that it is precisely similar to those of the Junior Division. It is a lamentable fallacy and one we would like to see dispelled.

BOAT CLUB

IN Eights 1924 we again had a fairly successful week, making four bumps. On the first day we bumped Worcester II, and on the second day Ch. Ch. II, in spite of the fact that No. 4's slide broke just as we got our 'one gun'. On Saturday we were stopped by a sinking boat in the Gut and lost our chance of bumping New College II; but were fortunate in having two gaps behind us at the time. On Monday we had a lapse and Queen's II overlapped us in the Gut, but—owing largely to Tufton's excellent stroking—we got away, and left them three-quarters of a length behind at the finish. It only remains to be hoped that next year more of the gentlemen who encourage us vociferously from the stand will come and give us more active assistance.
