

COLLEGE NOTES

OLD members will have heard with deep regret of Dr. Cruttwell's death. It was all the more lamentable in that he seemed from last autumn onwards to have been making a real recovery at last, after more than two years of severe illness; all that time he was in nursing homes, for a long time in Bath and finally near Bristol. Those who saw him last Christmas at Bristol were much encouraged by the progress he had made, by his recovery of vitality, and by the improvement in his spirits. His death was due to heart failure under an operation which his doctors considered would lessen the chances of a relapse. An obituary notice is printed on a later page.

The College has naturally still further diminished in numbers, though the rooms are full with contingents from Keble as well as Oriel, and with those who have come here for special courses. Sometimes there are almost as many up in vacation as in term, either because they are working for S.T.C. and other certificates, or doing spells of hard labour on 'national work', or merely because they have no very obvious alternative. One advantage of this fact is that the College is well supplied with fire-watchers in the vacation as well as in term. Regular squads have been organized, and one of the strangest sights of the present period is to see the Dean showing undergraduates the best way of climbing over the College roofs.

Some information about members of the College serving with the Forces is included in this number, but it is feared that it is not always up to date; corrections and additions would be welcomed. The deaths on service of Sqd.-Leader J. G. Macintyre, A. Fl.-Officer A. Munro of the R.A.F., L.A.C. R. Pennington of the Fleet Air Arm, and 2nd Lt. M. E. C. A. Freeman of the 60th Rifles, are recorded with great regret. Macintyre was a Classical Scholar who joined the Air Force after taking Schools in 1934; Pennington, the younger brother of Alan Pennington, only spent a single term here before volunteering for service. Munro and Freeman came up together in the autumn of 1935 and both went down before the end of 1936, but Freeman returned to the College early in 1939 and was in residence until the end of the year.

The problem of Air Raid Precautions has involved the College in two separate questions, the provision of material and the maintenance of services. The first has proved sufficiently formidable. The adequate 'blacking-out' of the Hall and other public rooms, of private sets and staircases, together with the supply of such fire-fighting equipment as stirrup-pumps, buckets, sandbags, the means of access to roofs and a modest issue of 'tin hats', has cost little less than £1,000 in money and a corresponding expenditure of time, energy, and patience on the part of the Bursar.

The maintenance of services offers a different problem in term and in vacation. The large number of undergraduates resident in term has enabled a comprehensive scheme to be devised, which includes a fire brigade, a rota of fire-watchers, and the allotment of separate sections to deal with incendiaries in lofts and attics; while the hardier spirits have undertaken to sublimate their adventurous impulses upon the roofs. We have also undertaken to send assistance to All Souls and—with what some may consider exemplary self-sacrifice—to the Indian Institute.

The vacation, on the other hand, presents obvious difficulties. So far these have been overcome by the co-operation of Fellows, staff, and such undergraduates as the claims of the Senior Training Corps or the interests of their own work have kept in Oxford. For the immediate future the situation has been eased by the presence of a number of Cadets who are to be resident in the College throughout the summer. So far as can be seen, therefore, the essential requirements will be met without calling upon outside help, at least until the close of the present year.

It should, perhaps, be added that there is in the College both a public Air-Raid Shelter and a Air-Raid Wardens' Post, but for these, of course, the College accepts no responsibility.

IN MEMORIAM

C. R. M. F. CRUTTWELL

CRUTTWELL'S connexion with the College began in 1912, soon after his election to a fellowship at All Souls, when he took over some of the teaching at Hertford in the school of modern history. Absent from Oxford during the war, he became a Fellow of Hertford on his return in 1919 and before long was appointed Dean. His health, which had been seriously and permanently affected by the war, was subjected to a severe strain during the following years, for in addition to the duties of the Deanship and a heavy burden of tuition, due to the unprecedented number of undergraduates resident in the post-war period, he had to find time for his work as a member of the Statutory Commission. The result of his exertions was a breakdown which fortunately proved to be temporary; after a period of convalescence he was able to resume his College activities, with the exception of the Deanship. He held a University Lectureship in Modern History from 1926 to 1930, when on the resignation of Buchanan-Riddell he became Principal at the age of 42. A long and successful tenure of the Principalship seemed to be in store for him, but after a few happy years he was again stricken down by illness, and in 1939 he resigned. The circumstances of his sudden death are recorded elsewhere in this number.

When Cruttwell resigned the Principalship his great services to the College were recognized by his election to an Honorary Fellowship. During the twenty years in which he had been a member of the Governing Body of the College he had played an important part in the direction of its policy, for, in addition to sound judgement and a natural talent for business, he possessed a detailed knowledge of the problems of university administration which he had acquired on the Statutory Commission and as a member of the Hebdomadal Council. His reputation as a historian also conferred distinction on the College to which he belonged. At first his fame was mainly confined to Oxford, where it was based on his great success as a teacher, spread abroad by his pupils, and on the raciness of his lectures, of which many stories were told, not all apocryphal. He had not written much until he became Principal, but the leisure from teaching conferred on him by his new office enabled him to fulfil his long-cherished ambition to write a history of the last war. For this task he was well qualified by his experiences during the war, first with his regiment on the western front, and later on the Military Intelligence

Staff at the War Office. The result was his finest book, *A History of the Great War*, which was acclaimed by critics as the best work on the subject in a single volume, and which won from the University the degree of Doctor of Letters for its author. During his principalship he also wrote a valuable *History of Peaceful Change in the Modern World* and an excellent short life of Wellington.

Above all, Cruttwell during his connexion with Hertford gave to the life of the College the stimulus of a vigorous and unconventional personality. He was a favourite with undergraduates, who delighted in the picturesque outspokenness of his conversation, which has been compared to the art of a brilliant caricaturist. But the great popularity which he enjoyed with them was not based merely on the pungency of his language; it was a tribute justly earned by his sympathy with their pursuits, his genuine interest in their welfare, and the fundamental sincerity of his nature. His solid qualities also earned for him the respect and affection of his colleagues, who knew that in spite of his irresponsible sallies in conversation they could trust his considered judgement on men and things. He was sometimes brusque and impatient, for he endured much physical suffering and was seldom free from pain, but if he was not without faults they were minor blemishes in a fine character, which combined a scholar's passion for knowledge and an unswerving devotion to duty with a great capacity for friendship and a readiness at all times to help others in their difficulties. In his will he left to the College his historical books and a sum of £1,000; it was his final gift to the College which he had served so well.

H. B. GOODING

The College lost one of its most distinguished scholars by the death in April 1941 of Harry Beaujon Gooding. Coming to Hertford as a Classical Scholar from Barbados in October 1906, he obtained First Classes in Classical Mods., 'Greats', and Theology. His tutors included the present Bishop of Carlisle (Dr. Williams), the late Bishop of Ripon (Dr. Burroughs), and Norman Whatley (subsequently Headmaster of Clifton). His academic distinctions were not limited to successes in Schools, for his University Honours included a Liddon Studentship in 1910, the Junior Greek Testament Prize in 1911, and the Denyer and Johnson Scholarship in 1912. Ordained in 1912, he joined the Wycliffe Hall staff, being Vice-Principal 1912-14, and for the duration of the war took up parochial work. In 1919 he became Principal of Wycliffe Hall, and helped to establish it as one

of the foremost theological colleges in the country. His ability as theologian, philosopher, and administrator was recognized throughout the University, and to his judgement frequent appeal was made by members of the Theological Faculty.

Mr. Gooding was a close personal friend of Dr. Headlam, the Regius Professor, and of Canon B. H. Streeter of Queen's. He helped to create the Oxford Ordination Course; he was a member of the Oxford Committee on Faith and Order, and also of the Central Advisory Council for the Training for the Ministry. By the senior members of the University who knew him he was held in high esteem, and his character and talents won for him the affection and admiration of a succession of pupils. During his Principalship at Wycliffe Hall the intellectual life of the Hall reached an almost unique level. He took his B.D. in 1924. Perhaps the greatest tribute to his capacity as a scholar was the invitation which he received in 1922 to join the Archbishops' Doctrinal Commission.

Unfortunately for Oxford, and indeed for the Anglican Church in this country, and to the great regret of his many friends, he was forced to resign in 1925 by reason of his own ill health and that of his family. For their sakes and his own he went back to Barbados. He taught at Harrison College from 1926 to 1932, when he was appointed Headmaster of Lodge School, St. John's, Barbados, an office which he held until he died. He was an examining chaplain to several bishops. His death leaves a great gap in the ranks of Evangelical scholarship.

COLLEGE CLUBS AND SOCIETIES

THE BOAT CLUB

LAST Trinity Term found the numbers of the Boat Club slightly lower than the preceding term. In preparation for War-time Eights, which were not to affect the starting order after the war, the first Eight came up a few days early. We had lost two of last term's first colours and one Torpids colour.

As no official encouragement was given to colleges putting on boats of their own, the Club decided once more to combine crews with Oriel. Many changes were made in the first crew, and the Chaplain was unable to coach in the middle of the term, so that the crew, at first made to realize the importance of balance and time, never fully regained its prior steadiness, after a distinct lapse.

The second combined Eight started practising early in the term, but it was a long time before they settled down in a fixed order, mainly owing to the difficulties of choosing crews out of two clubs. Owing to changes of coach and to their being deprived of their stroke a fortnight before the races, they could only show some promise.

The races started with ill omen. G. F. Sharland, coxswain of the first Eight, and G. St. John Ives, stroke of the third Eight, reported sick. The third Eight provided several thrills. On the first day they were overlapping St. John's and Worcester third boat at Weirs Bridge, but at that moment stroke came off his slide and thus lost the bump. On the second day they were within a few feet of St. John's and Worcester, but failed to bump them. After a good row on the third day they bumped St. Catherine's second boat in front of Hertford Barge. Owing to an obstruction on the fourth day they were bumped by St. Catherine's but in the re-row the latter were unable to bump them owing to some excellent coxing.

The second Eight bumped St. Edmund Hall and Queen's second boat the first day, and were counted as having rowed over the second day owing to the premature firing of the starting gun and a resultant collision. Twice on the third day they were within a quarter of a length of Jesus, and on the fourth day they rowed over.

The first crew were bumped by Christ Church and B.N.C., and the second day rowed over, keeping well away from St. John's and Worcester. Owing to a very bad start and to a following wind on the third day, St. John's and Worcester took advantage of their unsteadiness, but only came within a few feet of them. They chased

St. Edmund Hall and Queen's hard all the way home on the fourth day, but failed to bump them.

In the Michaelmas term the remaining colours came up to find that the newly elected officers for the term—R. H. Atkinson to be Captain and G. St. John Ives to be Secretary—had failed to come up. The former had rowed in the first Eight his first term. This was a great loss to the Club.

We were very sorry to hear that the Chaplain was no longer able to coach us, as he has done with great energy since Michaelmas term, 1937. The club thanks him for his interest and trouble.

For the coming year G. F. Sharland was elected Captain and K. Wedgwood Hon. Secretary.

At a Captains' meeting it was decided to hold races for coxswainless fours in the first division, clinker fours in the second division, and tub fours in the third division. Races were to be rowed in heats of two at a time in a knock-out competition. After many reshufflings of the crews five fours were put on the river in combination with Oriel. Our Captains were both coxswains, so that arrangements for coaching were difficult, and could not remain permanent. The crews rarely became used to one coach, and thus progress was slow and unsteady. It was disappointing to watch all five crews being knocked out on the first day. We were younger and much less experienced than other crews.

In the Hilary Term, 1940, our numbers were reduced by half, and this seems to have been the case with other colleges, for it was decided to continue rowing in inter-collegiate boats. There was virtually no college rowing this term. D. I. Carnachan represented Hertford in one crew, and the Secretary was to have rowed in another, which never materialized.
